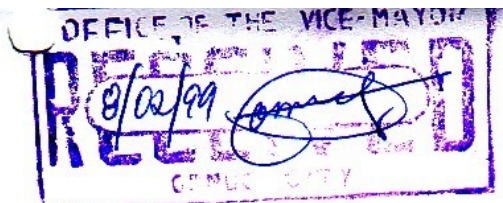
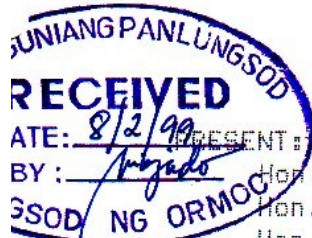

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR., TO ENTER INTO AND SIGN A COMPREHENSIVE HEALTH CARE AGREEMENT WITH THE DEPARTMENT OF HEALTH, WITH HONORABLE ALBERTO G. ROMUALDEZ, JR., M.D., AS SECRETARY OF HEALTH AND REPRESENTED BY DR. LILIA OBSEQUIO - ARTECHE, M.D., C.P.H. REGIONAL DIRECTOR, DEPARTMENT OF HEALTH (DOH) REGIONAL FIELD OFFICE NO. VIII, TACLOBAN CITY.

WHEREAS, this august Body is in receipt of 1st Indorsement dated 12 July 1999 from the Honorable City Mayor Eufrocino M. Codilla, Sr., of the Comprehensive Health Care Agreement between the Department of Health and the City Government of Ormoc and requesting for the passage of a resolution authorizing him to sign said agreement
