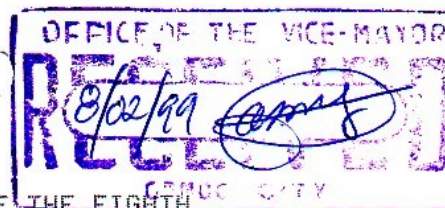

A RESOLUTION ADOPTING THE COMPREHENSIVE AND INTEGRATED DELIVERY OF SOCIAL SERVICES (CIDSS) PROGRAM AND AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR., TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REPRESENTED BY ITS REGIONAL DIRECTOR AIDA P. DOMINGO, DSWD FIELD OFFICE VIII, TACLOBAN CITY.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 15 July 1999 from the Office of the City Mayor re: letter of Ms. Aida P. Domingo, Regional Director, DSWD, Regional Office No. 8, requesting for a Sangguniang Panlungsod resolution adopting the Comprehensive and Integrated Delivery of Social Services program and authorizing the local chief executive to enter into a memorandum of agreement with the DSWD;

WHEREAS, said Memorandum of Agreement (MOA) mentions of the Comprehensive and Integrated Delivery of Social Services, a program wherein the DSWD and the City Government of Ormoc bind themselves through a Memorandum of Agreement (MOA) to build the capabilities of disadvantaged families and communities and facilitate access to basic services through various programs with a direct funding augmentation from the DSWD for a period of 3 years after which, the program will be turned over to the City Government, to commence upon signing of the MOA;

WHEREAS, the Sangguniang Panlungsod ng Ormoc has considered said request reasonable, hence, same be given due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Dennis Y. Capuyan, Chairman, Committee on Health, Public and Social Welfare, severally seconded by City Councilor Chiqui B. Labagala, Alfredo F. Capahi and Nepomuceno P. Aparis I; be it
