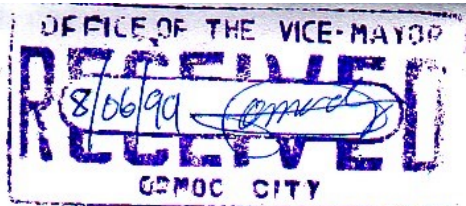

CITY;


ADOPTED, August 5, 1999.

-all in Ormoc City;


