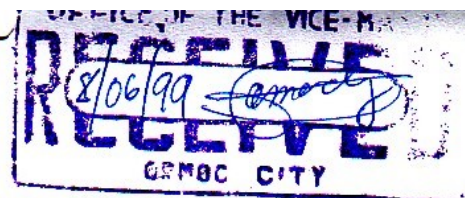
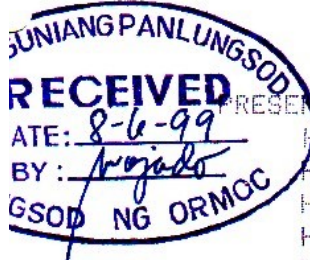

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ENFROCINO M. CODILLA, SR., TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH REPRESENTED BY DR. LILIA O. ARTECHE, DIRECTOR IV, FOR THE IMPLEMENTATION OF THE LOCAL GOVERNMENT UNIT PERFORMANCE PROGRAM - MATCHING GRANT PROGRAM.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 27 July 1999 from the Honorable City Mayor re: copy of Memorandum of Agreement (MOA) between the Department of Health and the City Government of Ormoc with a request for authority to sign for and in behalf of the City Government of Ormoc said MOA;


