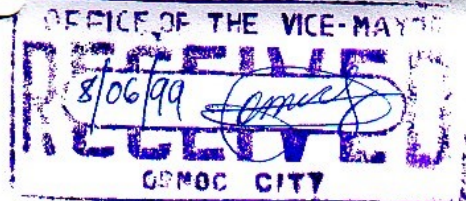
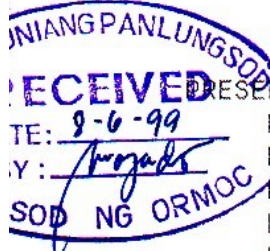

RESOLUTION NO. 99-127

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR OF
ORMOC, EUFROCINO M. CODILLA, SR., TO FILE THE
CORRESPONDING COMPLAINT FOR THE SETTLEMENT OF BOUNDARY
DISPUTE BETWEEN THE CITY OF ORMOC AND THE MUNICIPALITY
OF KANANGA, LEYTE, WITH THE PROPER COURT.

WHEREAS, this august Body is in receipt of a letter dated 30 July
1999 from the Honorable City Mayor of Ormoc, Eufrocino M. Codilla, Sr.,
requesting for the passage of a resolution authorizing him to file the
corresponding complaint for the settlement of the boundary dispute
between the City of Ormoc and the Municipality of Kananga before the
proper court, copy of said letter hereto attached for ready reference;

WHEREAS, it can be recalled that efforts have been made by this
City to settle the existing boundary dispute with the Municipality of
Kananga, Leyte, amicably, but the same proved futile;

WHEREAS, for purposes of resolving the issue, it is but proper to
bring this matter to the proper court for adjudication so that it can be
decided on the merits and that the same will be resolved once and for
all;

WHEREAS, this august Body has considered said request reasonable
and valid, hence, the same be given due course of action;

WHEREFORE, foregoing premises considered, on MASS MOTION of the
BODY; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution
AUTHORIZING THE HONORABLE CITY MAYOR OF ORMOC, EUFROCINO M. CODILLA,
SR., TO FILE THE CORRESPONDING COMPLAINT FOR THE SETTLEMENT OF BOUNDARY
DISPUTE BETWEEN THE CITY OF ORMOC AND THE MUNICIPALITY OF KANANGA,
LEYTE, WITH THE PROPER COURT.
