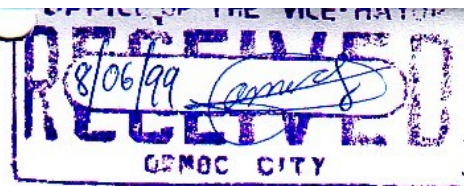
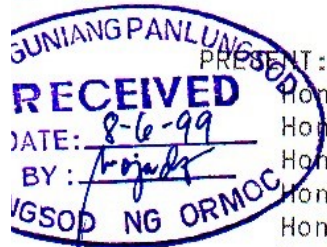

RESOLUTION NO. 99-128

A RESOLUTION APPROVING THE GUIDELINES JOINTLY SUBMITTED BY THE OIC-CITY TREASURER AND WATERWORKS SUPERINTENDENT, THIS CITY, CONTAINED IN THEIR LETTER ATTACHED THERETO FOR THE PROPER IMPLEMENTATION OF ORDINANCE NO. 99-02, ENTITLED, "AN ORDINANCE ADOPTING A REVISED SCHEDULE OF WATER AND SERVICE FEES FOR THE CONSUMERS/USERS OF THE ORMOC WATERWORKS SYSTEM (ORWASA) THEREBY AMENDING THE PERTINENT PROVISIONS OF TAX ORDINANCE NO. 1, OTHERWISE KNOWN AS THE ORMOC CITY REVENUE CODE OF 1977, AND FOR OTHER PURPOSES".

WHEREAS, this Sanggunian is in receipt of the proposed guidelines jointly submitted by the OIC-City Treasurer and Waterworks Superintendent for the proper implementation of the Ordinance No. 99-02, entitled, "AN ORDINANCE ADOPTING A REVISED SCHEDULE OF WATER AND SERVICE FEES FOR THE CONSUMERS/USERS OF THE ORMOC WATERWORKS SYSTEM (ORWASA) THEREBY AMENDING THE PERTINENT PROVISIONS OF TAX ORDINANCE NO. 1, OTHERWISE KNOWN AS THE ORMOC CITY REVENUE CODE OF 1977, AND FOR OTHER PURPOSES";

WHEREAS, said guidelines is submitted in compliance with Section 5 of said Ordinance quoted hereunder to wit:

"SECTION 5. The Office of the City Treasurer of Ormoc and ORWASA shall take the necessary steps or adopt measures to bill the water consumers immediately, and adopt the mechanics for the proper implementation of this Ordinance which shall be submitted to the Sanggunian for review and approval;"

WHEREAS, this Sanggunian finds aforementioned Guidelines in order as it is fair, reasonable and equitable hence, it must be given due course of action;



WHEREFORE, foregoing premises considered, on motion of City Councilor Mariano Y. Corro, Chairman, Committee on Ways and Means, jointly seconded by City Councilors Claudio P. Larrazabal and Chiqui B. Labagala; be it




