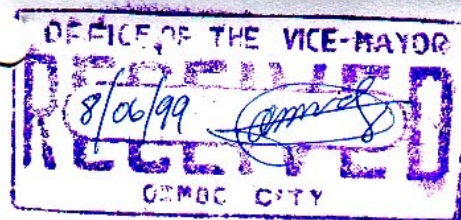
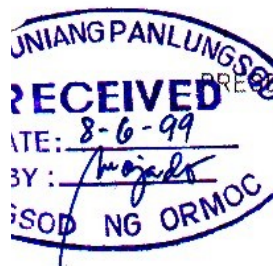

Councilors Chiqui B. Labagala and Fernando P. Parrilla; be it


RESOLVED, to pass a resolution APPROVING THE APPLICATION FOR THE


