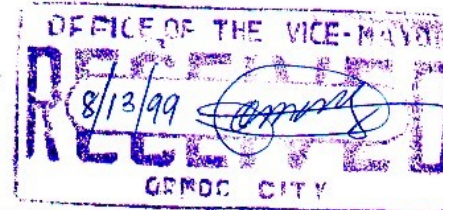


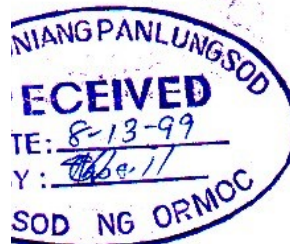

RESOLUTION NO. 99-131

A RESOLUTION APPROVING ORDINANCE NO. 99-03 OF THE  
SANGGUNIANG BARANGAY OF R.M. TAN, THIS CITY, ENTITLED:  
"AN ORDINANCE IMPOSING THE INCREASE OF BARANGAY  
CLEARANCE FEE ON BUSINESS ESTABLISHMENT, EMPLOYMENT,  
TRAVEL ABROAD, MARRIAGE, ENROLMENT AND CHARACTER  
VERIFICATION IN THE BARANGAY."

WHEREAS, this Sanggunian is in receipt of Ordinance No. 99-03 of  
the Barangay R.M. Tan, this city, entitled, "AN ORDINANCE IMPOSING THE  
INCREASE OF BARANGAY CLEARANCE FEE ON BUSINESS ESTABLISHMENT,  
EMPLOYMENT, TRAVEL ABROAD, MARRIAGE, ENROLMENT AND CHARACTER  
VERIFICATION IN THE BARANGAY."

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the  
aforecited ordinance at issue (and all other ordinances of the  
Sangguniang Barangay in Ormoc City), is by law, granted the Power of  
Review as to whether said ordinance is consistent with law and city X X  
X ordinances; (Sec. 57, 1991, LGC)

WHEREAS, it is the observation of this august Body, through the  
representation of the Honorable Chairman, Committee on Laws and  
Ordinances that the aforesaid ordinance has conformed to pertinent  
provisions of the Local Government Code, hence, reasonable and within  
the province of the Sangguniang Barangay of Brgy. R.M. Tan to legislate;

WHEREFORE, foregoing premises considered, on motion of City  
Councilor Nepomuceno P. Aparis I, Chairman, Committee on Laws and  
Ordinances, severally seconded by City Councilors Dennis Y. Capuyan,  
Sotero M. Pepito and Chiqui B. Labagala; be it
