RESOLUTION NO. 99-135

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR., TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, AS DONOR, A DEED OF DONATION IN FAVOR OF BARANGAY LAO, ORMOC CITY, INVOLVING A PARCEL OF LAND KNOWN AS LOT NO. 6279 - PART, WITH AN AREA OF ONE THOUSAND FOUR HUNDRED THIRTY THREE (1,433) SQUARE METERS INCLUDING ALL THE IMPROVEMENTS FOUND THEREON, COVERED BY AND DESCRIBED IN T.C.T. NO. 12398, IN REGISTRY OF DEEDS, ORMOC CITY.

WHEREAS, the Sanggunian is in receipt of 1st Indorsement dated 05 August 1999 from the Honorable City Mayor Eufrocino M. Codilla, Sr., requesting for the passage of resolution authorizing him to sign for and in behalf of the City Government of Ormoc a Deed of Donation in favor of Brgy. Lao, this city, involving a parcel of land lot no. 6279 - Part situated at Brgy. Lao, Ormoc City with an area of ONE THOUSAND FOUR HUNDRED THIRTY THREE (1,433) square meters covered by T.C.T. No. 12398;

WHEREAS, the Brgy. Council of Brgy. Lao, this city passed a Resolution No. 12, S. 1999 entitled, "A RESOLUTION EARNESTLY REQUESTING THE GOVERNMENT OF ORMOC CITY THRU THE SANGGUNIANG PANLUNGSOD NG ORMOC AUTHORIZING HIS HONOR, EUFROCINO M. CODILLA, SR., CITY MAYOR, ORMOC CITY TO DONATE AND SIGN THE DEED OF DONATION INTER VIVOS OF LOT NO. 6279 - PART KNOWN AS LAO MULTIPURPOSE CENTER WITH AN AREA OF 1,433 SQUARE METERS, MORE OR LESS IN FAVOR OF BARANGAY LAO, ORMOC CITY";

WHEREAS, the City Legal Officer through his 4th Indorsement dated 03 August 1999 has stated that "the request of Brgy. Lao as embodied in its Resolution No. 12 series of 1999 is meritorious considering that the original intention is to donate 1,433 sq. meters to Brgy. Lao. However, in the Deed of Donation the Donee is the City Government of Ormoc. Thus, the request is corrective in nature";

WHEREFORE, premises considered, on motion of City Councilor Mariano Y. Corro, Chairman, Committee on Public Properties, severally seconded by Councilors Claudio P. Larrazabal, Dennis Y. Capuyan and Chiqui B. Labagala; be it

RESOLVED, AS IT IS HEREBY RESOLVED to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR., TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, AS DONOR, A DEED OF DONATION IN FAVOR OF BARANGAY LAO, ORMOC CITY, INVOLVING A PARCEL OF LAND KNOWN AS LOT NO. 6279 - PART, WITH AN AREA OF ONE THOUSAND FOUR HUNDRED THIRTY THREE (1,433) SQUARE METERS INCLUDING ALL THE IMPROVEMENTS FOUND THEREON, COVERED BY AND DESCRIBED IN T.C.T. NO. 12598, AND DESCRIBED IN REGISTRY OF DEEDS, ORMOC CITY;

ADOPTED, AUGUST 12, 1999.

RESOLVED, FURTHER, to furnish copies of this resolution each to His Honor, the City Mayor, the City Administrator, the Register of Deeds, the City Engineer, the General Services Department, the Barangay Chairman of Barangay Lao and others concerned, in Ormoc City;
