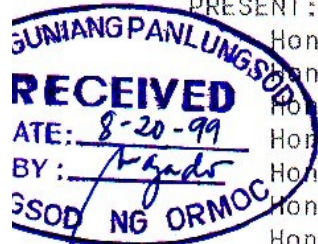

ORMOC CITY;


