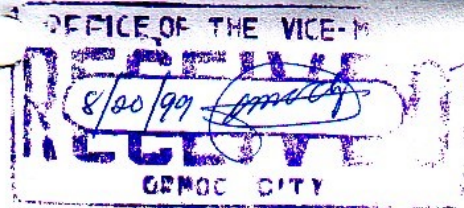
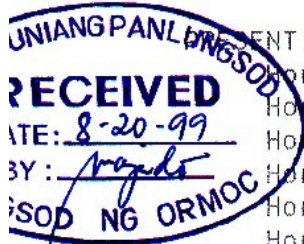

ORMOC CITY;

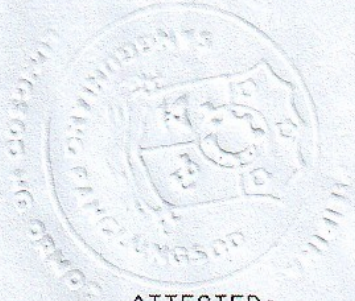




