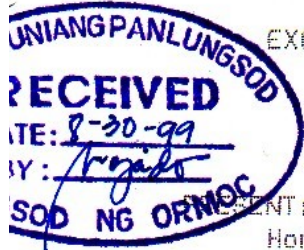

RESOLUTION NO. 99-141

A RESOLUTION APPROVING THE APPLICATION FOR ALTERATION OF
PLAN OF VILLA THERESA HEIGHTS SUBDIVISION FROM B.P. 220
- ECONOMIC TO P.D. 957 OPEN MARKET IN SELECTED
LOCATIONS, INVOLVING LOTS 5232-A, LOCATED AT BARANGAY
SAN ISIDRO, ORMOG CITY WITH A TOTAL LAND AREA OF 70,160
SQUARE METERS AND SUBDIVIDED INTO 540 LOTS FROM 555
LOTS EXCLUDING COMMUNITY FACILITIES, ROAD LOTS, PARK
AND PLAZA, PROVIDED ALL THE CANALS AND DRAINAGE WILL
FOLLOW THE STANDARD REQUIREMENTS OF P.D. 957.

WHEREAS, for consideration by this August Body is the following:

"An application for alteration of plan of Villa Theresa
Heights Subdivision from B.P. 220 - Economic to P.D. 957
open market in selected locations, with Development Permit
No. 002-97 under B.P. 220 - Economic as per S.P. Resolution
No. 97-227 dated November 27, 1997, comprising lot Nos.
5232-A, and 5232-B located at Barangay San Isidro, Ormoc
City with total land area of 70,160 square meters and
subdivided into 540 lots from 555 lots excluding community
facilities, lots, park and plaza."

WHEREAS, based on site inspections and re-evaluations conducted, it
has been found out that said application is in accordance with the
provision of P.D. 957, E.O. 648 and R.A. 7160 and its implementing rules
and regulations;

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution APPROVING THE APPLICATION FOR ALTERATION OF PLAN OF VILLA THERESA HEIGHTS SUBDIVISION FROM B.P. 220 - ECONOMIC TO P.D. 957 OPEN MARKET IN SELECTED LOCATIONS, INVOLVING LOTS 5232-A, LOCATED AT BARANGAY SAN ISIDRO, ORMOC CITY WITH A TOTAL LAND AREA OF 70,160 SQUARE METERS AND SUBDIVIDED INTO 540 LOTS FROM 555 LOTS EXCLUDING COMMUNITY FACILITIES, ROAD LOTS, PARK AND PLAZA, PROVIDED ALL THE CANALS AND DRAINAGE WILL FOLLOW THE STANDARD REQUIREMENTS OF P.D. 957;
