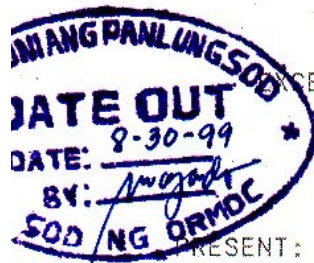
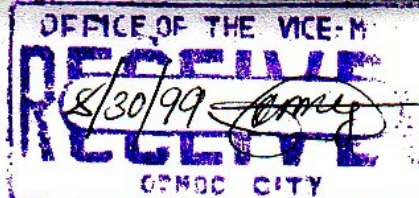
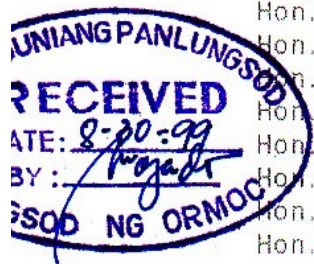

RESOLUTION NO. 99-142

A RESOLUTION SUPPORTING RESOLUTION NO. 99-229 OF THE
SANGGUNIANG PANLUNGSOD OF NAGA CITY, ENTITLED:
"RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY,
PRESIDENT JOSEPH EJERCITO ESTRADA TO CONSIDER THE
COMPUTATION OF THE UNION OF LOCAL AUTHORITIES OF THE
PHILIPPINES (ULAP) IN THE ALLOCATION OF THE INTERNAL
REVENUE ALLOTMENT (IRA) TAX COLLECTION AMOUNTING TO
P259,706,163,000.00 AND THE INTERNAL REVENUE ALLOTMENT
FOR LOCAL GOVERNMENT UNIT SHARE IN THE AMOUNT OF
P103,882,000,000.00".

WHEREAS, this Sanggunian is in receipt of Resolution No. 99-229
from the Sangguniang Panlungsod ng Naga, entitled: "RESOLUTION EARNESTLY
REQUESTING HIS EXCELLENCY, PRESIDENT JOSEPH EJERCITO ESTRADA TO CONSIDER
THE COMPUTATION OF THE UNION OF LOCAL AUTHORITIES OF THE PHILIPPINES
(ULAP) IN THE ALLOCATION OF THE INTERNAL REVENUE ALLOTMENT (IRA) TAX
COLLECTION AMOUNTING TO P259,706,163,000.00 AND THE INTERNAL REVENUE
ALLOTMENT FOR LOCAL GOVERNMENT UNIT SHARE IN THE AMOUNT OF
P103,882,000,000.00";

WHEREAS, said resolution has stated that under the computation of
Internal Revenue Allotment (IRA) done by the Union Local Authorities of
the Philippines, the total Internal Revenue Allotment of Local
Government Units totaled to around P103,882,000,000.00 is much higher
than the figures computed by the Department of Budget and Management
(P96.780 Billion) and by the Bureau of Internal Revenue (P102.551
Billion), and once the total amount of IRA as computed by the Union of
Local Authorities of the Philippines (ULAP) be allocated to all Local
Gov't. Unit the same would satisfy the delivery of basic services and
would completely cover the planned programs and projects of all LGUs for
the calendar year thereby benefiting their constituents;

WHEREAS, this august Body through the representation of the Honorable Chairman, Committee on Finance expresses its concern by way of this resolution of support for the reasons stated thereto;

WHEREFORE, foregoing premises considered, on motion of Councilor Alfredo F. Capahi, Chairman, Committee on Finance, severally seconded by Councilors Jose S. Serafica, Dennis Y. Capuyan and Eduardo P. Tan; be it

RESOLVED, to pass a resolution SUPPORTING RESOLUTION NO. 99-229 OF THE SANGGUNIAN PANLUNGSOD OF NAGA CITY, ENTITLED: "RESOLUTION EARNESTLY REQUESTING HIS EXCELLENCY, PRESIDENT JOSEPH EJERCITO ESTRADA TO CONSIDER THE COMPUTATION OF THE UNION OF LOCAL AUTHORITIES OF THE PHILIPPINES (ULAP) IN THE ALLOCATION OF THE INTERNAL REVENUE ALLOTMENT (IRA) TAX COLLECTION AMOUNTING TO ₱259,706,163,000.00 AND THE INTERNAL REVENUE ALLOTMENT FOR LOCAL GOVERNMENT UNIT SHARE IN THE AMOUNT OF ₱103,882,000,000.00";
