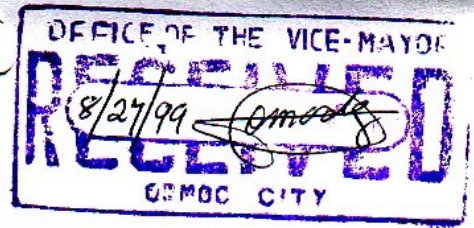


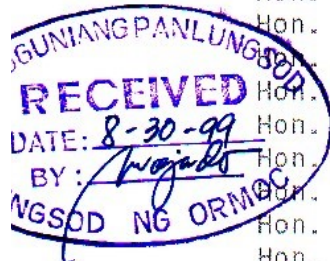

Y. Capuyan, Chiqui B. Labagala and Mariano Y. Corro; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to approve the REQUEST FOR


