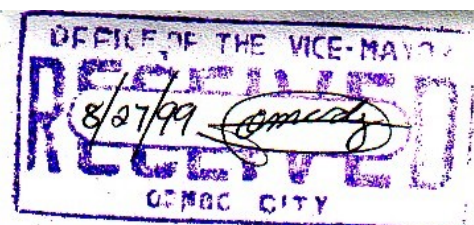


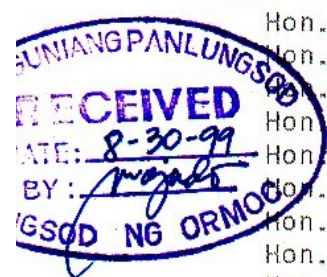

ADOPTED, August 26, 1999.



Valley, -all in Ormoc City;





