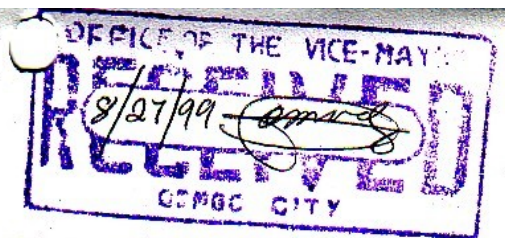
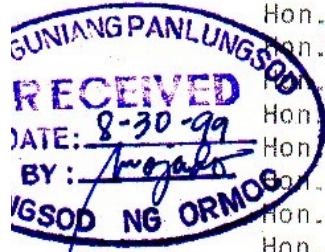


ADOPTED, August 26, 1999.


