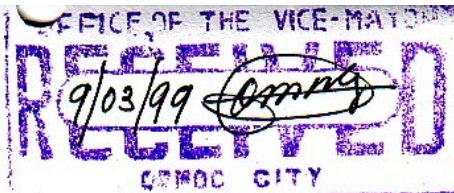


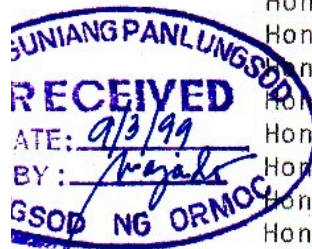

BUDGET NO. 01 OF BARANGAY R.M. TAN, THIS CITY;


