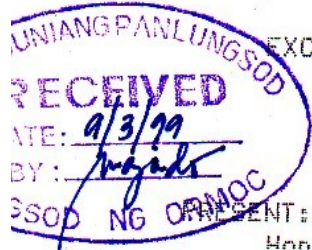

A. RESOLUTION EARNESTLY SUPPORTING HOUSE BILL NO. 7842
SPONSORED BY CONGRESSMAN HEHERZON ALVAREZ EXPANDING THE
PRE-SCHOOL EDUCATION PROGRAM OF THE GOVERNMENT.

WHEREAS, Education is the single most important intervention in
combating poverty and ending child labor;

WHEREAS, the existing pre-school education program is being carried
out in selected pilot areas of the country;

WHEREAS, under House Bill 7842 the expanded pre-school education
program would be carried out in the existing day-care centers in
barangay communities all over the country;

WHEREAS, under House Bill 7842, day care workers would be trained
to handle childhood education, nutrition, value formation, and safety
and psychological training;

WHEREAS, House Bill 7842 aims to make pre-schooling part of free
compulsory basic education for every citizen which is mandatory by the
constitution;

WHEREAS, it is imperative that this august Body supports the timely
passage of House Bill 7842 for basic education, a child finds it
difficult to develop and support himself and grow as an adult;

WHEREFORE, foregoing premises considered, on motion of City
Councilor Nepomuceno P. Aparis I, Chairman, Committee on Education,
jointly seconded by City Councilors Alfredo F. Capahi and Eduardo P.
Tan; be it
