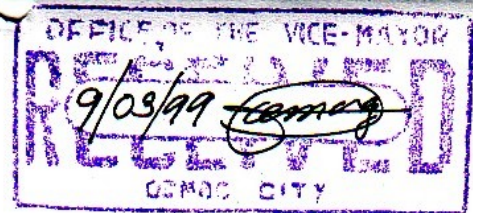
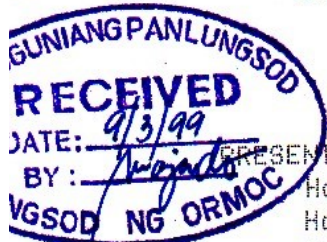

RESOLUTION NO. 99-152

A RESOLUTION INTERPOSING NO OBJECTION AND GRANTING SOCIAL ACCEPTABILITY TO THE POULTRY PROJECT OPERATION OF MR. RODOLFO D. RAMONEDA, BASED ON A RESOLUTION MADE AS A RESULT OF A PUBLIC HEARING FOR SAID PURPOSE CONDUCTED AT BARANGAY R.M. TAN, IN CONNECTION WITH HIS APPLICATION FOR ENVIRONMENTAL CLEARANCE (ECC).

WHEREAS, this Sanggunian is in receipt of Resolution No. 8 series of 1999 of Barangay R.M. Tan, this city, entitled: "A RESOLUTION EARNESTLY REQUESTING THE CITY FOR THE ISSUANCE OF THE CITY PERMIT IN OPERATING THE POULTRY PROJECT OF RODOLFO RAMONEDA WHICH LOCATED IN SITIO ROTONDA, BRGY. R.M. TAN, ORMOC CITY;

WHEREAS, Mr. Rodolfo Ramoneda has applied for the issuance of an Environment Compliance Certificate with the Department of Environment and Natural Resources (DENR) in connection with the operation of a poultry project located in Sitio Rotonda, Barangay R.M. Tan, this city;

WHEREAS, upon proper consultation with the residents of Barangay R.M. Tan, same is socially accepted as manifested by the Barangay Resolution No. 8 dated August 21, 1999 provided that the operator will fully maintain the cleanliness of the poultry, by using chemicals not harmful to the residents and with proper waste disposal;
