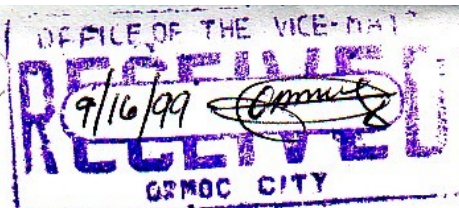
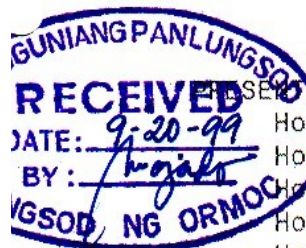



ADOPTED, September 15, 1999.


