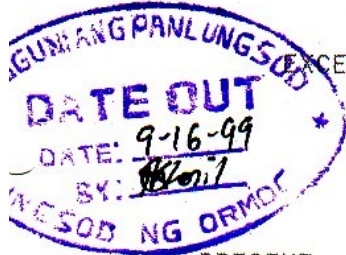
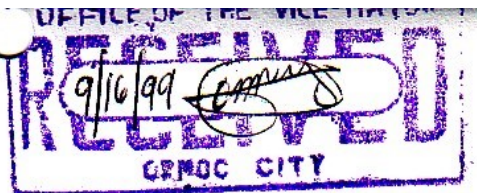
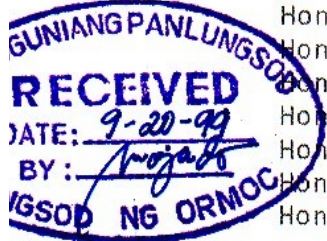

A RESOLUTION RESPECTFULLY AND EARNESTLY REQUESTING HIS  
EXCELLENCY PRESIDENT JOSEPH EJERCITO ESTRADA TO  
FAVORABLY ACT ON THE WITHIN RESOLUTION NO. 16, SERIES  
OF 1999 OF THE SANGGUNIANG PAMBARANGAY OF CAMP DOWNES,  
THIS CITY.

WHEREAS, this Sanggunian is in receipt of Resolution No. 16, Series  
of 1999 of the Sangguniang Pambarangay of Camp Downes, this city,  
entitled: "A RESOLUTION EARNESTLY REQUESTING THE CITY MAYOR HON.  
EUFROCINO M. CODILLA, SR., THRU SANGGUNIANG PANLUNGSOD (SIC) NG ORMOC  
TO ENDORSE THIS RESOLUTION MOST RESPECTFULLY HIS EXCELLENCY PRESIDENT  
JOSEPH EJERCITO ESTRADA TO SEGREGATE AND RECLASSIFY A PORTION OF CAMP  
DOWNES A MILITARY RESERVATION ESPECIFICALLY (SIC) NINE (9) HECTARES  
THEREOF INTO A BARANGAY CAMP DOWNES AND LOTS THEREIN TO BE SOLD TO THE  
ACTUAL RESIDENTS";

WHEREAS, the members of this Sanggunian unqualifiedly support and  
endorse to His Excellency President Joseph Ejercito Estrada the  
aforementioned Resolution of the Sangguniang Pambarangay of Camp Downes,  
as the same is reasonable, fair and equitable, considering the length of  
time that the residents have occupied the premises, and considering  
further, that they are mostly ex-military men or their widows and  
children;

WHEREAS, this Sanggunian has passed several resolutions of support  
and endorsement of the desire of the residents of the portion of the  
Camp Downes Military Reservation, to have the area occupied by them  
segregated and awarded to them, specifically Res. No. 66, dated July 13,  
1988, Res. No. 03, dated January 5, 1995, Res. No. 97-55, dated April 3,  
1997, Res. No. 97-110, dated June 19, 1997 and Res. No. 99-16, dated  
February 4, 1999, copies of which are hereto attached for ready  
reference;



WHEREFORE, on motion of Honorable City Councilor Mariano Y. Corro, Chairman, Committee on Public Properties, and co-authored by Honorable City Councilor Jose C. Alfaro, Jr., duly seconded by Honorable City Councilor Claudio P. Larrazabal; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution RESPECTFULLY AND EARNESTLY REQUESTING HIS EXCELLENCY PRESIDENT JOSEPH EJERCITO ESTRADA TO FAVORABLY ACT ON THE WITHIN RESOLUTION NO. 16, SERIES OF 1999 OF THE SANGGUNIANG PAMBARANGAY OF CAMP DOWNES, THIS CITY;
