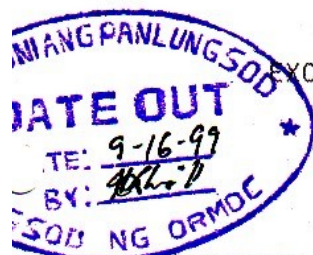
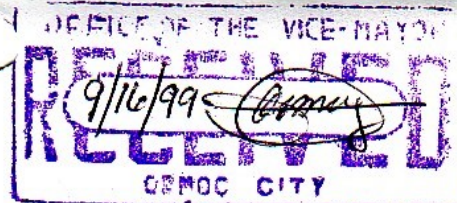
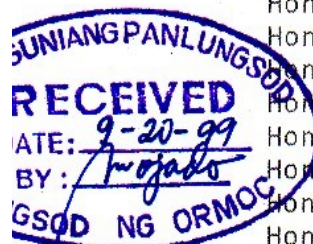

RESOLUTION NO. 99-160

A RESOLUTION AMENDING RESOLUTION NO. 98-24 DATED JULY 30, 1998 OF THE SANGGUNIANG PANLUNGSOD NG ORMOC APPROVING THE APPLICATION FOR DEVELOPMENT PERMIT OF RUVI VILLAGE III SUBDIVISION BY INCORPORATING B.P. 220 OR "SOCIALIZED HOUSING PROJECT" AS RECOMMENDED BY THE CITY PLANNING AND DEVELOPMENT OFFICE.

PRESENTED, for consideration by this august Body is the following:

A letter dated 31 August 1999 from Mr. Ruviniou E. Mendola, owner, Ruvi Village III Subdivision addressed the Honorable Members, 8th Sangguniang Panlungsod, Ormoc City requesting for amendment of Resolution No. 98-24 dated July 30, 1998, entitled, "A RESOLUTION APPROVING THE APPLICATION FOR DEVELOPMENT PERMIT OF RUVI VILLAGE III SUBDIVISION OWNED BY DOLORES E. MENDOLA AND RUVINIEU E. MENDOLA, LOCATED AT BARANGAY TAMBULILID, ORMOC CITY, COMPRISING LOT 1-A, PSD-083738-007113-D AND LOT NO. 5248-B-8-A, PSD-08-009246-D, HAVING A TOTAL PROJECT AREA OF 19,731 SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 30274 CONTAINING ONE HUNDRED EIGHTY THREE (183) SUBDIVISION LOTS EXCLUDING COMMUNITY FACILITIES, PARK AND PLAZA AND ROAD LOTS";

WHEREAS, based on the approved subdivision plan, site inspection and re-evaluation conducted on documents submitted, the requested amendment to incorporate B.P. 220 or "Socialized Housing Project" to SP Resolution 98-24 dated July 30, 1998 is in accordance with the provisions of P.D. 957, B.P. 220, E.O. 648, R.A. 7279 and R.A. 7160 and its implementing rules and regulations;
