






WHEREAS, as stated in said Resolution, the major problem of the residents of Sitio Coob, Brgy. Libertad is water supply and the extension of water line system from Brgy. San Isidro to Sitio Coob is the only possible solution to answer the urgent needs of the residents, considering that the area has low water level;

WHEREAS, it is the consensus of this august Body, that the term reversion as originally used be changed to realignment considering the nature of the funds being utilized;




