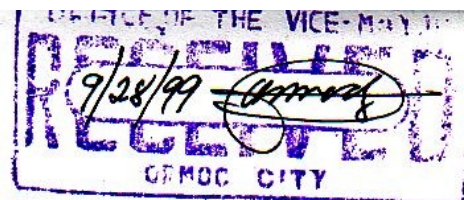
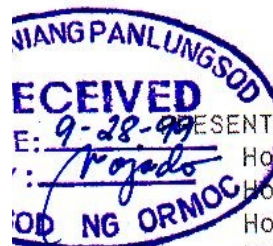

RESOLUTION NO. 99-164

A RESOLUTION ADOPTING THE STRATEGIC AGRICULTURE AND
FISHERIES DEVELOPMENT ZONES (SAFDZ) OF ORMOC CITY.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 13 September 1999 from the Honorable City Mayor Eufrocino M. Codilla, Sr., copy of the Strategic Agriculture and Fisheries Development Zones (SAFDZ) of Ormoc City and requesting this august Body to pass a resolution adopting the same;

WHEREAS, as can be gleaned from the Strategic Agriculture and Fisheries Development Zone Map, the strategic fishery sub-development zones are well identified, the areas covered are mostly our municipal waters;

WHEREAS, it can also be recalled that the City of Ormoc has also a twenty (20) hectare lot area of fish sanctuary located between the Barangays of Danhug and Macabug and that the city's municipal waters are also considered areas for development;

WHEREAS, the Sangguniang Panlungsod ng Ormoc has considered said request reasonable, hence, same be given due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Claudio P. Larrazabal, Chairman, Committee on Agriculture, duly seconded by City Councilor Fernando P. Parrilla; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution ADOPTING THE STRATEGIC AGRICULTURE AND FISHERIES DEVELOPMENT ZONES (SAFDZ) OF ORMOC CITY.
