RESOLUTION NO.

A RESOLUTION RESPECTFULLY AND EARNESTLY REQUESTING THE CHAIRNAN, CIVIL SERVICE COMMISSION, HON. CORAZON ALMA CHAIRMAN, CIVIL SERVICE CUMMISSION, NOW. DESCRIPTION OF BUDGET AND DE SON, AND THE SECRETARY, DEPARTMENT OF BUDGET AND THE SECRETARY DICKNO. CLARIFICATION ON MANAGEMENT, NON. BENJAMIN DIOKNO, CLARIFICATION ON WHETHER OF NOT ELECTIVE OFFICIALS ARE ENTITLED TO THE SALARY STEP INCREMENTS PRESCRIBED IN SECTION 7 OF REP. ACT NO. 6758. OTHERWISE KNOWN AS THE "COMPENSATION AND POSITION CLASSIFICATION ACT OF 1989".

WHEREAS, the first paragraph of Section 4 of Rep. Act No. : 6758; provides: "COVERAGE - The Compensation and Position Classification System herein provided shall apply to all positions, appointive or ELECTIVE, on full or part-time basis, now existing or hereafter created in the government, including government-owned or controlled corporations and government financial institutions";

WHEREAS, Section 7 of the aforementioned law, prescribes the Salary Schedule which includes eight (8) salary step adjustments;

WHEREAS, Local Budget Circular (LBC) No. 64, dated January 22, 1997, paragraph 2 thereof, on COVERAGE provides: "All position whether permanent, temporary, contractual, casual or emergency in nature, appointive or ELECTIVE, on full-time or part-time basis now existing or hereafter created in the local government units (LGUs);

WHEREAS, paragraph 6 of the aforecited LBC No. 64, on COMPENSATION RULES, in part provides:

"6.2 Incumbents of positions shall receive the salary rates corresponding to their designated SALARY STEPS in the salary grade allocation of their position as of December 1996 for purposes of the adjustment effective January 1, 1997, and as of October 31, 1997 for purposes of the adjustment effective Movember 1, 1997."

WHEREAS, from the aforequoted provisions of Rep. Act No. 6758 and LBC No. 64, it can be reasonably and logically inferred that ELECTIVE OFFICIALS are likewise included in the SALARY STEP INCREMENTS Benefit as prescribed in Sec. 7 of Rep. Act No. 6758;

WHEREAS, very unfortunately ELECTIVE OFFICIALS are deprived and excluded from the SALARY STEP INCREMENTS benefit;

WHEREAS, DBM Circular No. 1 which took effect on January 1, 1990, particularly Rule I, Section 1 thereof, states that it is applicable only to officials and employees who are APPOINTED on a permanent status in the career service, thereby excluding ELECTIVE OFFICIALS from its coverage;

WHEREAS, aforementioned DBM Circular No. 1 was adopted and promulgated prior to the effectivity of the Local Government Code of 1991 which took effect on January 1, 1992, hence does not embrace the ELECTIVE OFFICIALS elected under the provisions of the Local Government Code of 1991;

WHEREAS, as stated earlier the provisions of Rep. Act No. 6758 likewise applies to ELECTIVE OFFICIALS, hence any implementing rules and regulations promulgated thereunder cannot diminish nor should diminish the benefits provided therein. As pronounced by our Supreme Court in the case of BIENVENIOO MARQUEZ, JR., versus COMELEC, ET AL, G.R. No. 112889, promulgated on April 18, 1995, "An administrative rule or regulation can neither expand nor constrict the law but must remain congruent to it."

WHEREAS, it is the sense of this Sanggunian that justice, fairness and equity demand that the SALARY STEP INCREMENTS Benefit prescribed in Rep. Act No. 6738 be extended to ELECTIVE OFFICIALS;

WHEREFORE, foregoing premises considered, on motion of City Councilor Jose C. Alfaro, Jr., Vice Chairman, Committee on Ways and Means, Sponsored by City Councilor Mariano Y. Corro, jointly seconded by City Councilors Alfredo F. Capahi and Claudio P. Larrazabal; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution respectfully and earnestly requesting the Chairman, Civil Service Commission, Hon. Corazon Alma de Leon, the Secretary of the Department of Budget and Management, Hon. Benjamin Diokno, clarification on whether or not ELECTIVE OFFICIALS are entitled to the SALARY STEP INCREMENTS prescribed in Section 7, of Rep. Act No. 6758, otherwise known as the "Compensation and Position Classification Act of 1989";

ADOPTED, 30 September 1999.
