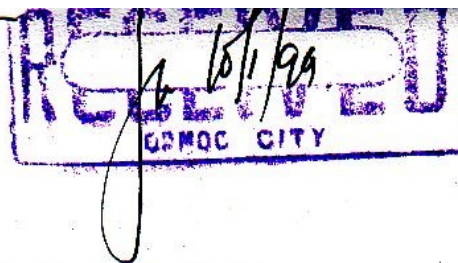
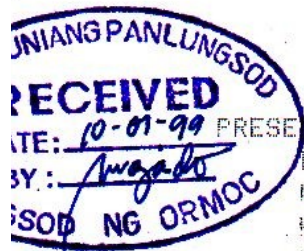

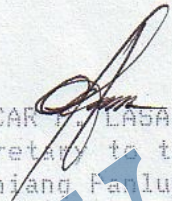

ADOPTED, September 30, 1999.

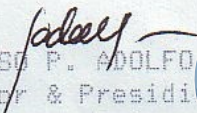
