NO. 03 OF BARANGAY SAN PABLO AND BARANGAY KADAOHAN, BOTH IN ORMOC CITY;

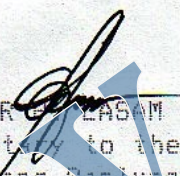

-all in Ormoc City;

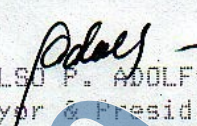
