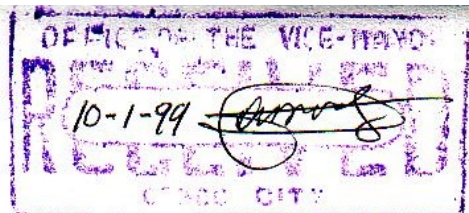
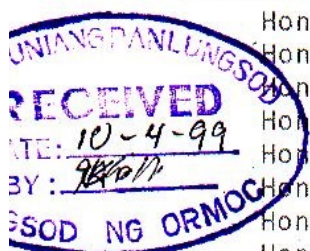

Abenio, Administrative Officer, City Administrator's Office, this city by deleting the items Emergency Shelter Assistance and Construction of Day Care Center at Lao Resettlement Area, both items with corresponding amount of Two Hundred Thousand Pesos (P200,000.00) each;
