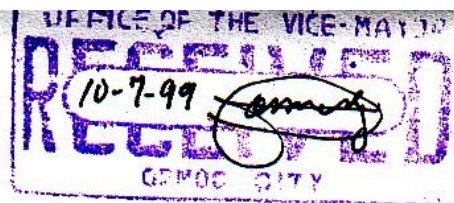




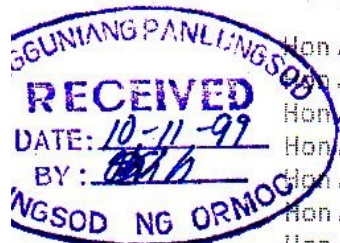

CITY;




