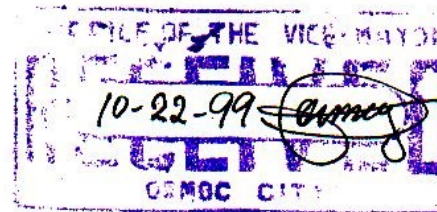
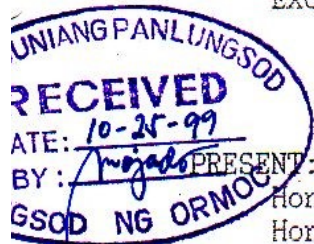

BUDGET NO. 02 OF BARANGAY DISTRICT 22, THIS CITY;



Chairman/Treasurer of Barangay District 22, -all in Ormoc City;


