## RESOLUTION NO. 99-173

A RESOLUTION RESPECTFULLY REQUESTING THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT, THROUGH HONORABLE SECRETARY RONALDO V. PUNO, FOR AN OPINION ON WHETHER OF NOT LEYECO V, AN ELECTRIC COOPERATIVE CREATED UNDER PD # 269, AS AMENDED, BUT NOT REGISTERED UNDER R.A. # 6938, IS EXEMPTED FROM THE PAYMENT OF THE REAL PROPERTY TAX, OR SUGGESTIVELY TO REFER THIS QUERY THE DEPARTMENT OF JUSTICE AND THE DEPARTMENT OF FINANCE.

WHEREAS, LEYECO V, an electric cooperative created under the provisions of PD 269, as amended, is, up to the present, not registered under the provisions of R.A. # 6938 however, under the aforecited PD 269, particularly Section 39 thereof, electric cooperatives organized thereunder are exempted from the payment of real property taxes;

WHEREAS, the Supreme Court in the case of MACTAN CEBU INTERNATIONAL AIRPORT AUTHORITY VS. HON. FERDINAND J. MARCOS, G.R. NO. 120882, ruled that tax exemption privileges have been withdrawn under Section 193, except those enumerated under Section 234 of the Local Government Code of 1991; (Please refer to the attached photocopy of the aforecited case which appeared in the LAWYERS REVIEW, Vol. X, No. 10, pages 28 to 35)

WHEREAS, the City Legal Officer of Ormoc, is of the opinion that LEYECO V is exempted from the payment of real property taxes; (Please refer to the attached photocopy, 2nd Indorsement, dated August 23, 1999 of the City Legal Officer)

WHEREAS, the Chairman, Committee on Ways and Means of this Sanggunian, is of the position that Leyeco V is not exempted from the payment of the real property taxes; (Please refer to the attached photocopy of his position paper entitled: "IS LEYECO V EXEMPT FROM THE PAYMENT OF THE REAL PROPERTY TAX?"

WHEREAS, this Sanggunian on September 2, 1999 passed Resolution No. 99-150 requesting the City Legal Officer to comment on the position paper submitted by the Chairman, Committee on Ways and Means; (Please refer to the attached photocopy of aforementioned resolution)

WHEREAS, the City Legal Officer in his letter dated October 14, 1999 addressed to the Vice-Mayor & Presiding Officer has suggested that the issue on whether or not LEYECO V is exempted from the payment of the real property taxes, be elevated to the Department of Justice; (Please refer to the attached photocopy of aforecited letter of the City Legal Officer)

WHEREAS, it is the observation of this Sanggunian that the Department of Justice declined to give opinions to queries referred to it by LGU's, hence this query is referred to your Department, especially that the legal question posed herein, refers to the proper implementation of the Local Government Code of 1991;

WHEREAS, attached hereto are photocopies of the pertinent/relevant papers consisting of 41 pages, for the information and guidance of the department concerned;

FOREGOING PREMISES CONSIDERED, on motion of Councilor Mariano Y. Corro, Chairman, Committee on Ways and Means, jointly seconded by Councilor Sotero M. Pepito and Alfredo F. Capahi, be it

RESOLVED, as it is hereby resolved to pass a RESOLUTION RESPECTFULLY REQUESTING THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT, THROUGH THE HONORABLE SECRETARY RONALDO V. PUNO, FOR AN OPINION ON WHETHER OR NOT LEYECO V, AN ELECTRIC COOPERATIVE CREATED UNDER PD # 269, AS AMENDED, BUT NOT REGISTERED UNDER R.A. # 6938, IS EXEMPTED FROM THE PAYMENT OF THE REAL PROPERTY TAX, OR SUGGESTIVELY TO REFER THIS QUERY TO THE DEPARTMENT OF FINANCE;
