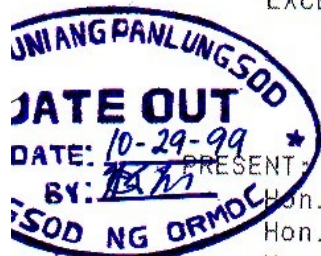

in Ormoc City;


