RESOLUTION NO. 99-176

A RESOLUTION APPROVING ORDINANCE NO. 99-001 SERIES OF 1999 OF BARANGAY NUEVA VISTA, THIS CITY, ENTITLED: "AN ORDINANCE PENALIZING PERSONS OR PERSON DESTROYING THE BARANGAY WATER SYSTEM, OR MAKING CONNECTIONS THEREOF WITHOUT A PRIOR AUTHORITY OR CONSENT FROM THE SANGGUNIANG PAMBARANGAY OF NUEVA VISTA".

WHEREAS, this Sanggunian is in receipt of Ordinance No. 99-001 series of 1999 from the Barangay Council of Barangay Nueva Vista, this city, entitled, "AN ORDINANCE PENALIZING PERSONS OR PERSON DESTROYING THE BARANGAY WATER SYSTEM, OR MAKING CONNECTIONS THEREOF WITHOUT A PRIOR AUTHORITY OR CONSENT FROM THE SANGGUNIANG PAMBARANGAY OF NUEVA VISTA";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the aforecited ordinance at issue (and all other ordinances of the Sangguniang Barangay in Ormoc City), is by law, granted the Power of Review as to whether said ordinance is consistent with law and city X X X ordinances; (Sec. 57, 1991, LGC)

WHEREAS, it is the observation of this august Body, through the representation of the Honorable Chairman, Committee on Laws and Ordinances that the aforesaid ordinance has conformed to pertinent provisions of the Local Government Code, hence, reasonable and within the province of the Sangguniang Barangay of Brgy. Nueva Vista to legislate;

WHEREFORE, foregoing premises considered, on motion of City Councilor Nepomuceno P. Aparis I, Chairman, Committee on Laws and Ordinances, severally, seconded by City Councilors Claudio P. Larrazabal, Alfredo F. Capahi and Eduardo P. Tan; be it
