

RESOLUTION NO. 99-176

APPROVING ORDINANCE NO. 99-001 SERIES OF A RESOLUTION 1989 OF BARANCAY NUEVA VISTA, THIS CITY, ENTITLED: ORDINANCE RENALIZING PERSONS OR PERSON DESTROYING BARANGAY NATER SYSTEM, OR MAKING CONNECTIONS THE A PRIOR AUTHORITY OR CONSENT FROM SANGGUNIANG PAMBARANGAY OF NUEVA VISTA".

WHEREAS, Sanggunian is in receipt of Ordinance No. 99-001 series of 1999 from the Barangay Council of Barangay Nueva Vista, this city entitled, "AN ORDINANCE PENALIZING PERSONS OR PERSON DESTROYING THE BARANGAY WATER SYSTEM, OR MAKING CONNECTIONS THEREOF WITHOUT A PRIOR AUTHORITY OR CONSENT FROM THE SANGGUNIANG PAMBARANGAY OF NUEVA VISTA";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the aforecited ordinance at issue (and all other ordinances of the Sangguniang Barangay in Ormoc City), is by law, granted the Power of said ordinance is consistent with law and city Review as to whether X X X ordinances; (Sec. 57, 1991, LGC)
