RESOLUTION NO.

A RESOLUTION DISAPPROVING BARANGAY TAX ORDINANCE NO. 001-79 SERIES OF 1799 OF BARANGAY PUNTA, THIS CITY, "AN ORDINANCE IMPOSING TAXES ON RETAILERS, EMTITLEDY BILLBOARDS, SIGNBOARDS, CLEARANCES, AND PERMITS"

WHEREAS, this Sanggunian is in receipt of Barangay Tax Ordinance 001-99 s. 1999 of Barangay Punta, this city, entitled: "AN ORDINANCE INFOGING TAXES ON RETAILERS, BILLBOARDS, SIGNBOARDS, CLEARANCES, BARANGAY PERMITS";

WHEREAS, the Sangguniang Panlungsod ng Ormoc in relation to aforecited ordinance at issue (and all other ordinances of Sangguniang Barangay in Ormoc City), is by law, granted the Power of Review as to whether said ordinance is consistent with law X X X ordinances; (Sec. 57, 1991, LGC)

WHEREAS, after review of said ordinance, this Sanggunian recommends for its disapproval for the following reasons to wit:

- Sec. 8 does not specify the exact amount to be paid (barangay a) clearance);
- Said ordinance failed to reproduce the original provision of b) Sec. 8 of same;
- There is inconsistency as to the date of the effectivity C) (1998) of said ordinance and the date of certification (1999);
- Original copy of said ordinance is nowhere to be found, hence, d) this Sanggunian cannot make the necessary corrections as to the provisions to be corrected since new copy is different from original.

WHEREFORE, foregoing premises considered, on motion of City Councilor Nepomuceno P. Aparis I, Chairman, Committee on Laws and Ordinances, duly seconded by City Councilor Dennis Y. Capuyan; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution DISAPPROVING BARANGAY TAX ORDINANCE NO. 001-99 SERIES OF 1999 OF BARANGAY PUNTA, THIS CITY, ENTITLED: "AN ORDINANCE IMPOSING TAXES ON RETAILERS, BILLBOARDS, SIGNBOARDS, CLEARANCES, AND BARANGAY PERMITS";
