

RESOLUTION NO. 99-178

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE THE AMOUNT OF SEVEN HUNDRED TWENTY EIGHT THOUSAND PESOS (P728,000.00) AGAINST THE ACCOUNT PRIOR YEARS OBLIGATION, A NON-OFFICE ACCOUNT IN THE 1999 ANNUAL BUDGET OF THIS CITY, FOR PAYMENT OF PRODUCTIVITY INCENTIVE BENEFITS (PIB) OF 364 CASUAL EMPLOYEES FOR CY 1998.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 25 October 1999 from the Hon. City Mayor Eufrocino M. Codilla Sr., requesting for an appropriation in the amount of Seven Hundred Twenty-Eight Thousand Pesos (P728,000.00) for the payment of Productivity Incentive Benefits (PIB) of the Three Hundred Sixty-Four (364) casual employees for CY 1998;

WHEREAS, the City Budget Officer through 4th Indorsement dated October 28, 1999 recommends that authority be granted to the City Accountant to charge the above request against Prior-Year's Obligation, a non-office account in 1999 Annual Budget;

WHEREAS, Mrs. Salud A. Rivera, OIC-City Treasurer, through 6th Indorsement dated October 29, 1999 has certified that fund is available to be charged against Prior-Year's Obligation a non-office account in our 1999 Annual Budget, subject however, to accounting and auditing rules and procedures;




