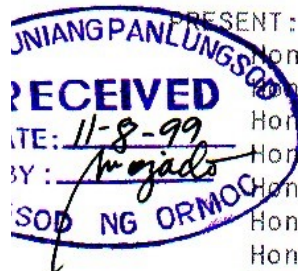

Councilors Sotero M. Pepito and Dennis Y. Capuyan; be it


RESOLVED, to pass a resolution APPROVING THE 1999 SUPPLEMENTAL

ADOPTED, November 04, 1999.


RESOLVED, FURTHER, to furnish copies of this resolution each to His
