RESOLUTION NO. 99-180

A RESOLUTION RESPECTFULLY REQUESTING THE BOARD OF
COMMISSIONERS OF HOUSING AND LAND USE REGULATORY BOARD
(HLURB) TO FURTHER EXTEND THE PERIOD TO COMPLY THE
CONDITIONS IN THE GRANTING OF CONDITIONAL APPROVAL TO
ORMOC CITY ZONING ORDINANCE NO. 62 S. 1997 TO MAY 20,
2000.

WHEREAS, the Office of the City Mayor, this city has endorsed to
the Hon. Chairman, Committee on Zoning & Beautification, the URBIS
Phils. Inc. final report of ORMOC CITY MASTER DEVELOPMENT AND
COMPREHENSIVE LAND USE PLAN WITH DRAFT ZONING ORDINANCE together with
CDC Resolution No. 02, s. 1998 for adoption and approval;

WHEREAS, after evaluation of the same by the Hon. Chairman,
Committee on Zoning and Beautification, the following defects were
disclosed to wit:

- 1) Standard attached map (Ormoc General Land Use Map and Ormoc Urban Land Use Map) of the draft Zoning Ordinance.
- 2) When the Ormoc General Land Use Map was submitted, it did not agree with the ORMOC MASTER DEVELOPMENT AND COMPREHENSIVE LAND USE PLAN.
- 3) Some description of the Zone Boundaries of the draft Zoning Ordinance could not be located/pinpointed on the submitted Ormoc General Land Use Map.
- 4) CDC Resolution No. 02 s. 1999 was approved but still subject to modification. Such modifications were not mentioned in the resolution so the committee required the secretariat of the CDC to submit the minutes of said meeting last December 05, 1998.

WHEREAS, the Honorable Chairman, Committee on Zoning and Beautification has obtained a copy of the President's Memorandum dated 09 October 1999 directing the DILG and HLURB to finalize the LGU's Comprehensive Land Use Plan until March 31, 2000 to fast track mass housing program;

WHEREAS, Ormoc City Ordinance No. 62 s. 1997 entitled, "Reclassifying An Area Identified As The Site of the Proposed Provincial Industrial Center of Leyte from Agricultural to Industrial Use" was conditionally approved by HLURB Board of Commissioners per Resolution No. R-619 s. 1998 and extended until November 20, 1999 per Resolution No. R-644 S. 1999;

WHEREFORE, foregoing premises considered, on MASS MOTION of the Body; be it


