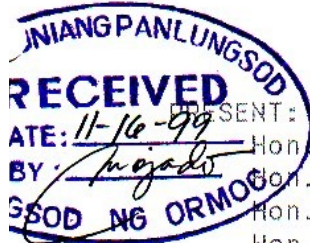

WHEREAS, this august Body is in receipt of 1st Indorsement dated 27
