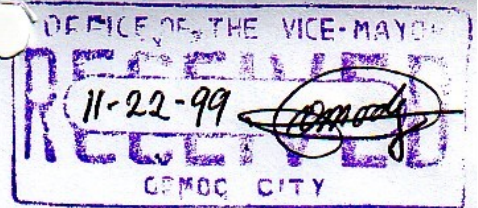
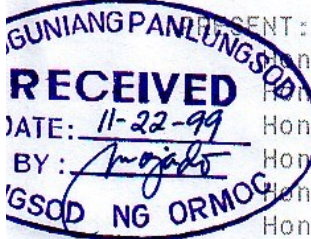

RESOLUTION NO. 99-191

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR., TO ENTER INTO AND SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT, FOR THE IMPLEMENTATION OF THE "LINGAP PARA SA MAHIRAP PROGRAM FUND" FOR THE FIVE (5) IDENTIFIED POOREST BARANGAYS IN ORMOC CITY.

WHEREAS, this august Body is in receipt of 1st Indorsement dated 27 October 1999 from the Honorable City Mayor Eufrocino M. Codilla, Sr., requesting for the passage of a resolution authorizing him to sign for and in behalf of the City of Ormoc, a Memorandum of Agreement (MOA) with the Department of Social Welfare and Development;
