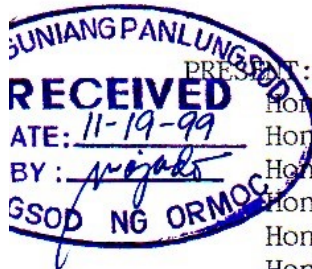

RESOLUTION NO. 99-192

A RESOLUTION RESPECTFULLY REQUESTING HIS EXCELLENCY,
JOSEPH EJERCITO ESTRADA, PRESIDENT, REPUBLIC OF THE
PHILIPPINES TO ALLOW THE CITY GOVERNMENT OF ORMOC TO
GRANT "EMPLOYEES' RELIEF ASSISTANCE PROVISIONS" (ERAP)
IN THE AMOUNT OF EIGHT THOUSAND PESOS (₱8,000.00) EACH
TO ALL EMPLOYEES IN THE LOCAL GOVERNMENT OF ORMOC.

WHEREAS, it has been observed that prices of gasoline and other petroleum products have gone up and has affected the prices of other prime commodities making it more difficult for the consumers to make both ends meet;

WHEREAS, ordinary employees especially those depending purely on salary eventually has to resort to borrowings just to enable them to have three (3) meals a day;

WHEREAS, considering that Christmas Season is almost at our doorsteps, ordinary employees like our local government employees, with their meager income, cannot buy extra goodies to bring joy to their families;

WHEREAS, the Sangguniang Panlungsod ng Ormoc finds it appropriate to ease the plight of its local government employees by providing some assistance to them, since the City of Ormoc has sufficient amount in savings, hence, this request;

WHEREFORE, foregoing premises considered, on MASS MOTION of the Body; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution RESPECTFULLY REQUESTING HIS EXCELLENCY, JOSEPH EJERCITO ESTRADA, PRESIDENT, REPUBLIC OF THE PHILIPPINES TO ALLOW THE CITY GOVERNMENT OF ORMOC TO GRANT "EMPLOYEES RELIEF ASSISTANCE PROVISIONS" (ERAP) IN THE AMOUNT OF EIGHT THOUSAND PESOS (₱8,000.00) EACH TO ALL EMPLOYEES IN THE LOCAL GOVERNMENT OF ORMOC;
