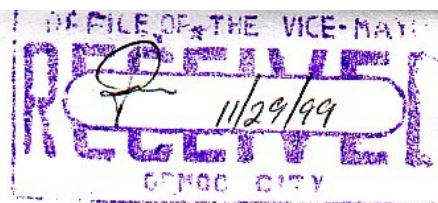
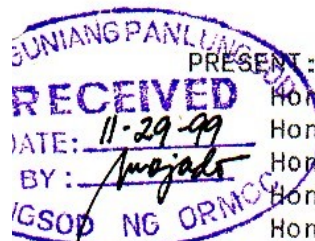

RESOLUTION NO. 99-197

A RESOLUTION APPROVING BARANGAY ORDINANCE NO. 18 SERIES OF 1999 OF BARANGAY LAKE DANAQ, THIS CITY, ENTITLED: "AN ORDINANCE ADOPTING A NORM OF CONDUCT TO BE ADHERED TO STRICTLY BY ALL RESIDENTS OF BARANGAY LAKE DANAQ, ORMOC CITY, PHILIPPINES IN ORDER TO MAINTAIN PEACE AND ORDER WITHIN THE METES AND BOUNDS OF BARANGAY LAKE DANAQ AND TO MAINTAIN AN ATMOSPHERE CONDUCIVE TO THE ATTRACTION OF VISITORS AND TOURIST TO THE AREA, EXCEPT THE PHRASE UNDER SECTION 5 OF SAID ORDINANCE WHICH READS "PLUS WHATEVER PUNISHMENT THE COURTS OF LAW MAY IMPOSE".

WHEREAS, this Sangguniang is in receipt of Ordinance No. 18 series of 1999 of the Barangay Council of Danao, this city, entitled: "A RESOLUTION ENACTING AN ORDINANCE MANDATING A NORM OF CONDUCT AMONG BARANGAY CONSTITUENTS IN THEIR DAILY INTER-RELATIONS WITH THEIR CO-BARANGAY RESIDENTS AND VISITORS AND TOURIST TO BARANGAY DANAQ, ORMOC CITY, PHILIPPINES";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the aforecited ordinance at issue (and all other ordinances of the Sangguniang Barangay in Ormoc City), is by law, granted the Power to Review as to whether the said ordinance is consistent with law and city X X X ordinances; (Sec. 57, 1991, LGC);

WHEREAS, it is the observation of this august Body, through the representation of the Honorable Chairman, Committee on Laws and Ordinances that the aforesaid ordinance has conformed to pertinent provisions of the Local Government Code, hence, reasonable and within the province of the Sangguniang Barangay of Barangay Lake Danao, to legislate;

WHEREFORE, foregoing premises considered, on motion of City Councilor Nepomuceno P. Aparis I, Chairman, Committee on Laws and Ordinances, jointly seconded by Councilors Dennis Y. Capuyan and Jose S. Serafica; be it

RESOLVED, to pass a resolution APPROVING BARANGAY ORDINANCE NO. 18 SERIES OF 1999 OF BARANGAY LAKE DANA0, THIS CITY, ENTITLED: "AN ORDINANCE ADOPTING A NORM OF CONDUCT TO BE ADHERED TO STRICTLY BY ALL RESIDENTS OF BARANGAY LAKE DANA0, ORMOC CITY, PHILIPPINES IN ORDER TO MAINTAIN PEACE AND ORDER WITHIN THE METES AND BOUNDS OF BARANGAY LAKE DANA0 AND TO MAINTAIN AN ATMOSPHERE CONDUCIVE TO THE ATTRACTION OF VISITORS AND TOURIST TO THE AREA, EXCEPT THE PHRASE UNDER SECTION 5 OF SAID ORDINANCE WHICH READS "PLUS WHATEVER PUNISHMENT THE COURTS OF LAW MAY IMPOSE";

ADOPTED, November 25, 1999.

RESOLVED, FURTHER, to furnish copies of this resolution each to His Honor, the City Mayor; the President, Liga ng mga Barangay ng Ormoc, the DILG-CGO and the Punong Barangay, Barangay Lake Danao; - all in Ormoc City;
