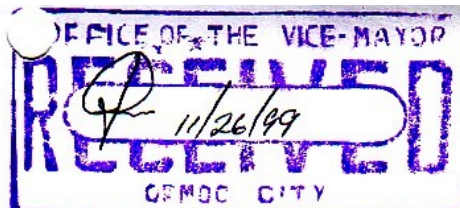
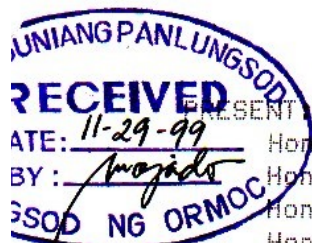

RESOLUTION NO. 99-199

A RESOLUTION AUTHORIZING THE CITY MAYOR TO RECEIVE FUND ASSISTANCE FOR THE PERSONS WITH DISABILITY OF ORMOC CITY SPECIFICALLY TO FINANCE THE BUSINESS MANAGEMENT SKILLS TRAINING AND TO TRANSACT BUSINESS WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 23 November 1999 from the Honorable City Mayor Eufrocino M. Codilla, Sr., re: Letter of Ms. Marietta S. Legaspi, City Social Welfare & Development Officer, requesting for the passage of a resolution authorizing the City Mayor to receive fund assistance for the Persons with Disability of Ormoc City specifically to finance the Business Management Skills Training and to transact business with the Department of Labor & Employment;

WHEREAS, said request is necessary for the release of said training grant based on the Project Proposal submitted to Department of Labor & Employment (DOLE) in the amount of FORTY NINE THOUSAND THREE HUNDRED PESOS ONLY (P49,300.00);

WHEREAS, the Sangguniang Panlungsod ng Ormoc has considered said request reasonable, hence, same be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Dennis Y. Capuyan, Chairman, Committee on Health and Social Welfare, severally seconded by City Councilors Fernando P. Parrilla, Jose C. Alfaro, Jr., and Chiqui B. Labagala; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE CITY MAYOR TO RECEIVE FUND ASSISTANCE FOR THE PERSONS WITH DISABILITY OF ORMOC CITY SPECIFICALLY TO FINANCE THE BUSINESS MANAGEMENT SKILLS TRAINING AND TO TRANSACT BUSINESS WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT;
