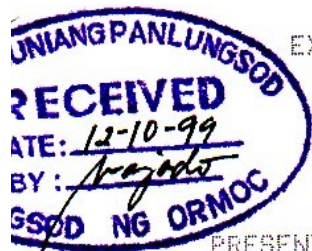

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR
EUFROCINO M. CODILLA, SR., TO ENTER INTO AND SIGN, FOR
AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A
MEMORANDUM OF AGREEMENT WITH THE NATIONAL FOOD
AUTHORITY (NFA) REPRESENTED HEREIN BY ITS PROVINCIAL
MANAGER, RAMON W. ASTILLA, TO ALLOW THE LOCAL
GOVERNMENT UNIT (LGU) TO PURCHASE RICE ON CREDIT FOR
RELIEF OPERATIONS WHENEVER A STATE OF CALAMITY IS
DECLARED IN ITS LOCALITY AND FOR STOCKPILING IN
PREPARATION OF EVENTUALITIES/EMERGENCIES THAT MAY OCCUR
AT ANY GIVEN TIME.

WHEREAS, this august Body is in receipt of 3rd Indorsement dated 1
December 1999 from Mr. Ruvinieu E. Mendola, Secretary to the Mayor,
copies of the Rice Loan Memorandum of Agreement between the National
Food Authority (NFA) and the City Government of Ormoc;

WHEREAS, said Memorandum of Agreement (MOA) mentions that the
National Food Authority (NFA) has acceded to the request of the Local
Government Unit (LGU) for a rice loan in cognizance to the needs of the
people in time of emergency and calamity;

WHEREAS, the City Legal Officer through 2nd Indorsement dated 29
November 1999 has stated that entering into this MOA will better prepare
the City of Ormoc in terms of rice supply during actual calamities and
emergencies considering that the LGU can immediately avail itself of
rice supply credit from NFA during such times;

WHEREFORE, foregoing premises considered, on motion of City Councilor Mariano Y. Corro, Vice Chairman, Committee on Laws and Ordinances jointly seconded by City Councilors Dennis Y. Capuyan and Chiqui B. Labagala; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M.
