

RESOLUTION NO. 99-210

RESOLVING RETURNING TO THE BARANGAY COUNCIL OF DANAO THEIR MARANGAY ORDINANCE NO. 17 SERIES OF 1999 FOR THE THAT SAID ORDINANCE IS ULTRA VIRES PER OPINION OF CITY LEGAL OFFICER CLETO L. EVANGELISTA, JR.

WHEREAS, this Sanggunian is in receipt of Ordinance No. 17 s. 1999 the Barangay Council of Barangay Danao, this city, entitled: ORDINANCE MANDATING THE IMPOSITION OF FEES ON CERTAION (SIC) VEHICLES THE BARANGAY ROAD WITHIN THE METES AND BOUNDS OF BARANGAY DANAO, ORMOC CITY, PHILIPPINES";

WHEREAS, the Sangguniang Panlungsod ng Ormoc is, by law granted the Power of Review as to whether said ordinance is consistent with law and city ordinance (Sec. 57, 1991, LGC);

WHEREAS, the City Legal Officer through 3rd Indorsement dated 29 November 1999 has stated that "it is beyond the power of the Barangay Council of Barangay Danao to enact Brgy. Ordinance No. 17 which imposes fees on the vehicles using their brgy. roads as provided in Sec. 133 (e) and that Sec. 152 of the LGC enumerates and governs the taxing power of the barangay clearly shows that brgy. has no such power";

WHEREFORE, foregoing premises considered, on motion of City Councilor Mariano Y. Corro, Vice Chairman, Committee on Laws and Ordinances, jointly seconded by City Councilors Dennis Y. Capuyan and Eduardo P. Tan; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution RETURNING TO THE BARANGAY COUNCIL OF DANAO THEIR BARANGAY ORDINANCE NO. 17 SERIES OF 1999 FOR THE REASON THAT SAID ORDINANCE IS ULTRA VIRES PER OPINION OF CITY LEGAL OFFICER CLETO L. EVANGELISTA, JR.;
