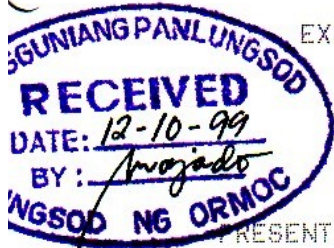
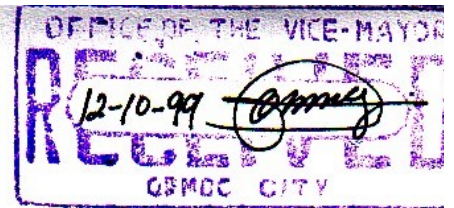

RESOLUTION NO. 99-211

A RESOLUTION AUTHORIZING REX MORALES CONSTRUCTION, REPRESENTED BY ENGR. REX E. MORALES, TO BILL AND COLLECT FROM THE DEPARTMENT OF JUSTICE, MANILA, FOR THE CONSTRUCTION OF ONE (1) COURTROOM, HALL OF JUSTICE (ANSALDO TYPE), IN ORMOC CITY, BASED ON ACTUAL WORK ACCOMPLISHMENT AND SUPPORTED BY A WORK ACCOMPLISHMENT, AND AFTER COMPLYING ALL OTHER REQUIREMENTS AS CALLED FOR IN THE MEMORANDUM OF AGREEMENT DATED JUNE 23, 1999 BETWEEN THE DEPARTMENT OF JUSTICE AND THE CITY GOVERNMENT OF ORMOC.

WHEREAS, this august Body is in receipt of 1st Indorsement dated 23 November 1999 from the Hon. City Mayor Eufrocino M. Codilla, Sr., anent the letter-request dated 19 November 1999 of Engr. Rex E. Morales, for an authority to collect billing from the Department of Justice, Manila, for the construction of one (1) courtroom, Hall of Justice Building (Ansaldo type), Ormoc City; (See attached copy)

WHEREAS, REX MORALES CONSTRUCTION, represented by Engr. Rex Morales is the winning bidder for the construction of one (1) courtroom, Hall of Justice (Ansaldo Type) in Ormoc City; (Please see attached copy of Contract and Agreement)

WHEREAS, based on the Inspection Report dated 10 November 1999 signed by the City Engineer, Antonio Z. Padayao, actual accomplishment as per scope of the contract is 60.35% completed and that payment of the same may be given due course subject however, to auditing and accounting rules and regulations;

WHEREAS, this august Body has considered said request reasonable, hence, same be accorded the necessary course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Mariano Y. Corro, Member, Committee on Finance, jointly seconded by City Councilors Dennis Y. Capuyan and Fernando P. Parrilla; be it
