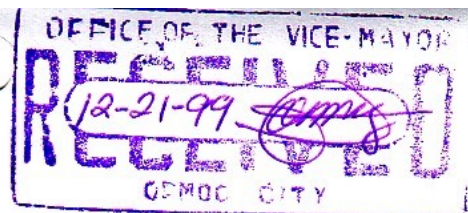
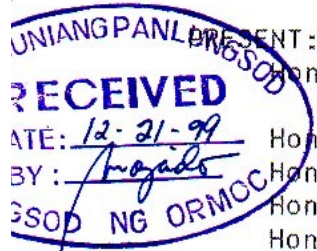

Mariano Y. Corro; be it


RESOLVED, to pass a resolution APPROVING THE 1999 SUPPLEMENTAL

ADOPTED, December 16, 1999.


RESOLVED, FURTHER, to furnish copies of this resolution each to His
