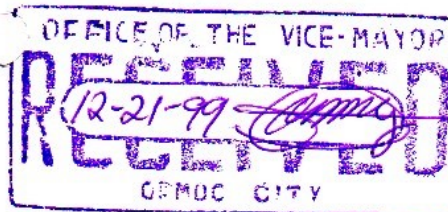
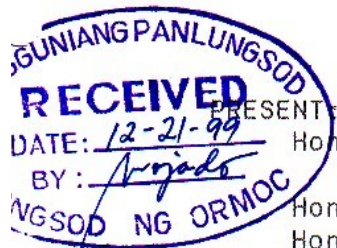

ADOPTED, December 16, 1999.


RESOLVED, FURTHER, to furnish copies of this resolution each to His
