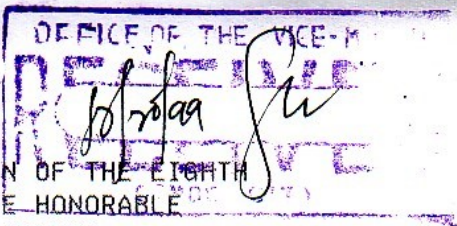

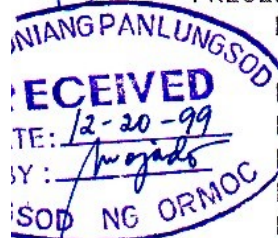

A RESOLUTION REQUESTING FOR ASSISTANCE FOR LAND
DEVELOPMENT OF RESETTLEMENT PROJECTS UNDER THE POVERTY
ALLEVIATION FUND-TWO (PAF-2) OF THE NATIONAL HOUSING
AUTHORITY IN THE AMOUNT OF ONE MILLION FIVE HUNDRED
FIVE THOUSAND (P1,505,000.00) PESOS.

WHEREAS, this august Body is in receipt of a letter dated 3
December 1999 from the Honorable City Mayor Eufrocino M. Codilla, Sr.,
with the information that an available fund in the amount of
P1,505,000.00 from the National Housing Authority Poverty Alleviation
Fund-Two (PAF-2) can be utilized by the City for the land development of
its resettlement projects;

WHEREAS, the Honorable City Mayor has considered the aforementioned
fund can be used in the concreting of road network of the JICA Flood
Mitigation Resettlement Project in Barangay Lao, Ormoc City thus,
requested this august Body to pass a resolution requesting the National
Housing Authority for the city to avail of the said Poverty Alleviation
Fund-Two;

since, this fund is a grant and would be of great help to the City
Government for the concreting of road network of the JICA Flood

this date, the City has no funds for the purpose;
