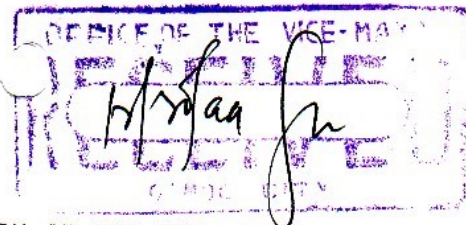
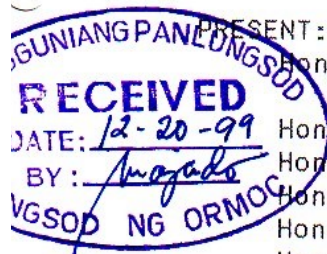

A RESOLUTION APPROVING THE JICA FLOOD MITIGATION  
RESETTLEMENT PROJECT AS THE RECIPIENT OF THE NATIONAL  
HOUSING AUTHORITY'S POVERTY ALLEVIATION FUND-TWO  
(PAF-2) PROJECT.

WHEREAS, this august Body is in receipt of a letter dated 3  
December 1999 from the Honorable City Mayor Eufrocino M. Codilla, Sr.,  
requesting for approval of the JICA Flood Mitigation Resettlement  
Project as the recipient of the Poverty Alleviation Fund-Two (PAF-2);

WHEREAS, the National Housing Authority Regional Office has an  
available fund under the said Poverty Alleviation Fund-Two (PAF-2) in  
the amount of P1.505 Million, which can be utilized by LGUs for the land  
development of resettlement projects;

City Government for the concreting of the road network of the JICA Flood
